## INVESTIGATION / ENFORCEMENT

### ELIGIBLE FOR IMMEDIATE CALLOUT:

---

- Fatal Fires
- Fires with Serious Injuries
- Incendiary Fires for which Local Investigators Feel they have Viable Suspects and Leads
- Major Businesses / Industries
- Major Apartment Complexes
- Certain Wildland Fires

### **NOT** ELIGIBLE FOR IMMEDIATE CALLOUT:

---

- Structure Fires with no Fatalities / Injuries
- Structure Fires Total Loss with no Fatalities / Injuries
- Vehicle Fires
- Tribal Fires
- Rubbish Fires
- Federal Sites, Buildings and Facilities

## INSPECTIONS

### DIVISION INSPECTORS WILL INSPECT:

---

- State-Owned, Leased, or Public Works Projects
- Health Care Facilities Upon Request of the State Health Department
- Child Care, Group Care and Family Care Facilities Upon Request of the State Health Department
- Institutions, Jails, Prisons as described in NAC 477
- Schools (Clark County Only)
- Hazardous Materials site or Facilities as described in NAC 477
- Commercial Buildings in areas of the State as described in NAC 477 (Only without signed Interlocal Agreements)
- Hotel, Motel, and Lodging Facilities as described in NAC 477

## INSPECTIONS

### INSPECTIONS **WILL NOT** BE CONDUCTED WITHOUT INVITATION FOR:

---

- Federal Sites, Buildings and Facilities
- Building, Facilities and Sites Located on Tribal Reservations
- Single-Family Dwellings, Sub-Divisions, Inclusive of Duplexes and Triplexes
- Commercial Businesses Conducted out of a Single-Family Dwelling
